Article 1 This announcement

“Commander” means a person who has the authority to give orders, supervise, follow up and

Check the police officers under your jurisdiction

“Bribe” means property or any other benefit given to a person to induce that person to act

“Performing duties” means the act or performance of duties of a government official in

“gifts or any other benefits that affect the performance of duties” means money

Property, services or any other benefits that have value and include tips. which government officials receive in addition toSalary, income, government benefits in normal cases and affecting decisions, approvals, and permissions or anything else in Perform duties in a manner that is beneficial in a dishonest way to the gift giver In the past or at the time of reception or in the future

Article 2: Police officers at all levels shall behave as follows:

1.1 Do not ask for advice, do not give or accept bribes, gifts, gifts or any other benefits from Performing duties

2.2 Do not consent or connive to family members giving or receiving bribes, gifts, or gifts or any other benefits to those involved in performing their duties

3.3 Performing duties must adhere to law enforcement with fairness, benefit, and

The image of the police is important. Must not do anything which is a conflict between personal interests and public benefits such as receiving gifts or any other benefits that affect practice

Article 3 The commander shall have the authority and duty to supervise, monitor and inspect the police officers under his supervision Behave in accordance with this announcement. In the event that an action is found that violates this announcement Report to the Superintendent/Station Head as soon as possible.

Article 4: Whoever finds an action that violates this announcement. You can complain/report clues directly through Superintendent of KhongChiam Provincial Police Station or via telephone number ໐໘໕-໓໐໒-໕໕໕໖ which information about the complainant/whistleblower will be concealed and kept strictly secret

Article 5 In the case of receiving a complaint/clue Affiliated personnel commit such offenses at the station The police will investigate the facts. And if an offense is found, the perpetrator will be punished as strictly stated in accordance with relevant laws, rules and regulations. and deliver matters in order Continued command
